DANGEROUS DRUGS ACTS,
1920 AND 1923.

WITHDRAWAL OF AUTHORISATION.

(DR. CHARLES HENRY JAMES ROBINSON).

Whereas Dr. Charles Henry James Robinson, M.R.C.S., L.R.C.P., lately of 28, Taswell Road, Southsea, and now of "Elmhurst," Bosham, Sussex, has been convicted of an offence against the Dangerous Drugs Acts.

And whereas the said Dr. Charles Henry James Robinson cannot, in my opinion, properly be allowed to be in possession of or supply raw opium or any of the drugs to which Part III of the Dangerous Drugs Act, 1920, applies.

Now, therefore, in pursuance of the powers conferred on me by No. 6 of the Raw Opium Regulations, 1921, and No. 12 of the Dangerous Drugs Regulations, 1921, I hereby give notice that I withdraw, as from to-day's date, from the said Dr. Charles Henry James Robinson the authorisations granted by the said Regulations to duly qualified medical practitioners to be in possession of and supply raw opium and the drugs to which Part III of the Dangerous Drugs Act, 1920, applies.
