FOOT-AND-MOUTH DISEASE: INFECTED PLACES.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

The several premises mentioned in the Schedule hereto are hereby declared to be places infected with Foot-and-Mouth Disease.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this nineteenth day of June, nineteen hundred and twenty-four

Description and Limits of Infected Places.

Northamptonshire.

1. The field known as Wheathill Field being part of Church Farm, in the occupation of Edward Thorne, in the parish of Harlestone, in the administrative county of Northampton.

Surrey.

2. All buildings, yards and fields known as Elm Farm, Sutton Common Road, in the parish of Sutton, in the administrative county of Surrey.
