before mentioned and hereinafter recommended and proposed will render the same Benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Wootton:

"Now, therefore, with the consent of the said Edward Alfred Mitchell Innes (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Hubert Murray, Bishop of Oxford (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Wootton, now vested in him, the said Edward Alfred Mitchell Innes as aforesaid, shall be transferred to the said Hubert Murray, Bishop of Oxford, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Hubert Murray, Bishop of Oxford, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Oxford.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say,

the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 1st day of May, 1924, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 39, and the Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Frankley, in the County of Worcester and in the Diocese of Birmingham:

"Whereas Charles George, Viscount Cobham, deceased, being then entitled in fee simple free from incumbrances to the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Frankley devised (inter alia) the said Advowson to the use of the Right Honourable John Cavendish, Viscount Cobham, during his life and died on the 9th day of June, 1922:

"And whereas the said Will with four Codicils thereto not affecting the said devise was duly proved by the Honourable Robert Henry Lyttelton, the Right Honourable Mary Susan Caroline, Downger Viscountess Cobham, and Walter Robert Buchanan Riddell, the

Executors therein named:

"And whereas the said John Cavendish, Viscount Cobham, is accordingly the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said John Cavendish, Viscount Cobham, is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Frankley should be transferred to and be vested in the Bishop of Birmingham for the time being:

the Bishop of Birmingham for the time being:

"And whereas the Right Reverend Henry Russell, now Bishop of Birmingham, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Henry Russell, Bishop of Birmingham, has executed this Scheme as hereinafter mentioned:
