BRISTOL (AVONMOUTH DOCK) IM-PORTED ANIMALS WHARF ORDER OF 1924.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Definition of Imported Animals Wharf.

1.—(1) The premises described in the First Schedule to this Order are hereby defined as an Imported Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1922, and any Order of the Minister thereunder for the landing of the animals described in the Second Schedule hereto; provided that whilst this Order remains in force the said premises shall be deemed to be excluded from and cease to form part of the Landing Place approved by the Minister of Agriculture and Fisheries, on the fifth day of December, nineteen hundred and twenty-three, for the purposes of Section 1 of the Importation of Animals Act, 1922 (Session 2) and of the Animals (Landing from Ireland, Channel Islands, and Isle of Man) Order of 1923.

(2) This Order shall cease to operate after the animals intended for immediate slaughter shall have been landed from the s.s. "Canadian Leader" and slaughtered in the Wharf and the carcases disposed of in accordance with the provisions of the Foreign Animals Order of 1910, and any Order of the Minister amending that Order.

Short Title.

2. This Order may be cited as the Bristol (Avonmouth Dock) Imported Animals Wharf Order of 1924.
