## BARRY GAS.

(Application for Special Order under Section 10 of the Gas Regulation Act, 1920.)

NOTICE is hereby given that the Urban District Council of Barry (hereinafter referred to as "the Council") whose address is the Council Offices, Holton Road, Barry, intend to apply forthwith to the Board of Trade under and in pursuance of Section 10 of the Gas Regulation Act, 1920, for a Special Order (hereinafter referred to as "the Order") for all or some of the following purposes (that

is to say):

1. To authorise the Council on the land hereinafter described to erect, construct, maintain, alter, extend, enlarge, improve and renew works for the manufacture, storage, conversion, utilisation and distribution of gas and residual products arising from, resulting in or producible from such manufacture, and to make and store gas and to purchase, make, and distribute utilise allresidual products and materials as aforesaid.

The land hereinbefore referred to is:-

All that piece of land situate in the parish of Barry in the county of Glamorgan (known as "The Verlon") situate on the northerly side of the road leading from Barry to Cardiff containing an area of 8 acres 1 rood and 30 perches or thereabouts, and comprising the enclosures numbered 53, 54 and 61 on the 2500 Ordnance Map for the said parish Edition of 1920 (Glamorgan Sheet No. XLVII. 13).

2. To enable the Council to purchase additional lands by agreement for and in connection with their gas undertaking, to confer powers upon them with regard to retention and disposal of lands, and to make provision as to the proceeds of sale of surplus lands.

3. To confer upon the Council further powers in regard to their gas undertaking and in particular in regard to the exemption of the Council from the obligation to supply gas when the capacity of the main is insufficient, the prescribing of the nature, size and

materials of pipes and fittings on consumers' premises, the recovery of expenses of re-connecting discontinued supply, the mode of cutting off of supplies of gas, the entering into premises and removal of fittings, etc., where gas supply discontinued, and the provision of valves where high pressure air is used.

- 4. To authorise the Council to borrow and raise money for and in connection with their gas undertaking and for paying the costs charges and expenses of the Order, and to charge the moneys so borrowed on the revenue of the gas undertaking and the district fund and general district rate, and to provide that moneys borrowed under the Order shall not be reckoned in the limit of borrowing prescribed by the Public Health Act, 1875.
- To vary or extinguish all rights, powers and privileges inconsistent with or which would or might in any way interfere with any of the objects of the Order and to confer other rights and privileges.
- To incorporate in the Order and apply with or without amendments all or some of the provisions of the Land Clauses Acts, the Gasworks Clauses Acts, 1847 and 1871, and the Acts amending the same, and to repeal, alter or extend all or any of the provisions of the Barry and Cadoxton Local Board (Gas and Water) Act, 1893, the Barry Urban District Council Act, 1896, and the Barry Urban District Council Act, 1913.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W. 1, and despatched on or before the 26th day of September, 1924.

Any such objection shall state-

(a) the specific grounds of objection; and (b) the omissions, additions or modifications asked for.

A copy of the objection must also be forwarded to the undermentioned Clerk or Parliamentary Agents at the same time as it is sent to the Board of Trade.

Printed copies of the draft Order and an ordnance map on a scale of not less than one inch to the mile showing the situation of the proposed works and of the existing works of the Council and the boundaries of the area in which the applicants are authorised to supply gas, and an ordnance map on the scale of 25 inches to the mile showing the land to be used for the construction of gas works have been deposited for public inspection at the Council Offices, Holton Road, Barry, and with the Clerk of the Peace for the County of Glamorgan at his office at the Glamorgan County Hall. Cardiff, and printed copies of the draft Order may be obtained at the Council Offices, Holton Road, Barry, and of the undermentioned Parliamentary Agents, at the price of one shilling for each copy.
