

(b) To authorise the Council to exercise within the area of supply the powers usually conferred on distributors of electrical energy.

2. The roads not repairable by the local authority and the railways which the Council propose to take special powers by the Order to break up are as follows:—

The following main roads repairable by the Durham County Council, viz.:—

Gateshead and Shotley Bridge Road from Crookgate to Pont Burn.

Lobley Hill and Lanchester Road from Crookgate to Flint Hill.

(1) *Private Roads*:—

(a) *Burnopfield*—

Front Chapel Avenue, Front Gibside Terrace, Front Co-operative Terrace, Front Park View, Front Park Terrace, East Approach to Wood Street and Cricket Terrace, Front Eden Avenue, Front West View, "The Fold" and Approaches thereto. Front and Back East View, Back Street "The Leazes" and West Approach to Back Street, Back High, Middle and Low Friarside Streets, Back of Syke Road Houses, Back Syke Lane Houses.

(b) *Hobson*—

Front Moyle, Robinson and Cawthorn Streets.

(c) *Pickering Nook*—

Back Wigham and Prospect Terraces, Back and Approach Edward Terrace, Approach and Back to Mountsett Street.

(d) *Tanfield*—

Back Wagon Row, Back Maud Terrace, Back and Approaches to Hawthorne Terrace, Back Bell View.

(e) *Tantobie*—

Front Elm Terrace, Front and Back John Street, Back Ash Terrace, Back Co-operative Terrace, Back Brick Row, Front and Back Martha Street, Back and Front Clarence Street, Back and Front Neale Street, Back and Front Owen Terrace, Front Federation Terrace, Front Mitchell Street, Front Bailey Street, North West Approach to Clarence and Martha Streets.

(f) *Tanfield Lea*—

Front Margaret Terrace, Front King Edward Street, Back Front Street, Back West Street, West Approach to George and Edward Streets.

(g) *White-le-Head*—

Back West Road Street, Front Bute Street, Corvan Terrace and Corvan Houses.

(h) *Flint Hill*—

Back Robson Terrace.

(2) *Bridges*:—

The roadways on the following bridges:—

(1) Carrying the road near Wester Leith Farm over the Tanfield Branch of the London and North Eastern Railway,

(2) Carrying the Shotley Bridge to Gateshead Main Road near Rose Cottage over the Railway of the South Garesfield Colliery Company Ltd., and

(3) The roadway on Derwent Bridge over the River Derwent at Rowlands Gill.

(3) *Level Crossings*:—

The level crossings over:—

(1) the London and North Eastern Railway at East Tanfield Road Ends, and at Causey near Causey Row, and

(2) the Pontop and Jarrow Railway near the bottom of Crookgate Bank and at the Top of Syke Road, South End.

3. To authorise the Council for the purpose of facilitating the supply of electricity within the proposed area of supply to break up the roads hereinafter mentioned outside the area of supply and to lay down or place electric lines or other works therein and to provide that the Council shall in respect of the said streets, electric lines and works have the same rights and be subject to the same obligations and liabilities as they would be subject to if the said streets, electric lines and works were situate within their area of supply.

The Streets hereinbefore referred to are as follows, viz.:—

(1) In the Urban District of Whickham—The road at Sheep Hill known as Busty Bank Road from the boundary of the Urban District of Tanfield at Front Street to Leap Mill Burn, and

(2) In the Urban District of Annfield Plain—The road at White-le-Head from a point Fifty yards to the West of Waggon Inn to the boundary of the Tanfield Urban District.

4. The names of the Streets and parts of streets in which it is proposed that electric lines shall be laid down within a period of two years after the commencement of the Order are as follows:—

Tantobie Road from Tanfield Church to the Four Road Ends at Tantobie; Clough Dene Road from the Four Road Ends at Tantobie to Pickering Nook; Syke Road from Pickering Nook to Leazes Church; Gateshead and Shotley Bridge Main Road from Leazes Church to Crookgate; Lobley Hill and Lanchester Main Road from Crookgate to Crookgate Bank Top; Barcus Close Lane from Crookgate Bank Top to Tanfield Church.

5. Every local or other public authority, company or person being desirous of bringing before the Electricity Commissioners any objection respecting the application may do so by registered letter addressed to the Secretary, Electricity Commission, Gwydyr House, Whitehall, S.W. 1, and despatched on or before the 24th day of September, 1924, and a copy of such objection must also be forwarded to the undersigned Clerk to the Council or Parliamentary Agents.
