It is agreed that the rate for Harvest Wagesin the County of Norfolk shall be £10 (TEN POUNDS).

The system of working by the Harvest or by the month shall be as hitherto, or by mutual arrangement between Employer and Workers.

Where the Harvest is worked by the month, it is to be understood that the same applies to twenty-four consecutive working days—the hours not to exceed seventy per week.

Boys to receive proportionate rates.
