FOOT-AND-MOUTH DISEASE:
INFECTED PLACE.

The premises mentioned in the Schedule hereto are hereby declared to be a place infected with Foot-and-Mouth Disease.

The Foot-and-Mouth Disease Infected Place (No. 1) described in the Schedule to the Order of the Minister dated 8th August, 1924 (No. 3713), is hereby extended so as to include the field known as Brook Meadow, being part of Court Farm, situated in the parish of Worminghall, in the administrative county of Buckingham, and in the occupation of Edgar Bury.

FECTED AREAS) ORDER OF 1924
(No. 138).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Extension of Infected Area (No. 11).

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 132) shall be read and have effect as if the Area described in the Schedule hereto were substituted for the Infected Area (No. 11) described in the Schedule to that Order, and the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 136) shall be read and have effect accordingly.

Revocation.

2. The Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 134) is hereby revoked.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 138).
