FOOT - AND - MOUTH DISEASE (IN-FECTED AREAS) ORDER OF 1924 (No. 189).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Declaration of Further Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be an Infected Area for the purposes of Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 70), hereinafter referred to as the principal Order.

## Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 139) and shall be read with the principal Order.

## ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General with the sanction of the Minister of Health, may from time to time alter Registration Sub-Districts:—

Now, therefore, I, Sylvanus Percival Vivian, Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Stockport Registration of Births (Alteration of Sub-districts) Order, 1924, and shall come into operation on the 1st day of September, 1924.
