

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to an Act of Parliament.

3. The Hazel Grove Sub-district of the Stockport Registration District shall cease to exist, and its constituent Civil Parishes shall be apportioned as follows:—

(a) The Civil Parish of Hazel Grove and Bramhall shall form a new Sub-district to be known as Hazel Grove Sub-district.

(b) The Civil Parish of Marple shall form a new Sub-district to be known as Marple Sub-district.

ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 8th August, 1924.)

Whereas under Section 11 of the Births and Deaths Registration Act, 1837, the Registrar General, with the approval of the Minister of Health, may divide any Union into two or more Superintendent Registrars Districts:—

And whereas it is expedient that the Birmingham Union, now divided into three Registration Districts, should henceforth be divided into two Registration Districts:—

Now, therefore, I, Sylvanus Percival Vivian, Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Birmingham Registration of Births, &c. Order, 1924, and shall come into operation on the 1st day of September, 1924.

2. The Aston, Birmingham, and King's Norton Registration Districts which, together form an area of the Birmingham Union, shall cease to exist and that Union shall be re-divided into two Superintendent Registrars Districts to be named Birmingham North and Birmingham South respectively.

3.—(a) The Birmingham North Registration District constituted by the Order shall consist of the existing Ladywood, All Saints and St. Mary's Sub-districts of the Birmingham Registration District, and the existing Duddleston, Aston and Erdington Sub-districts of the Aston Registration District.

(b) The Birmingham South Registration District constituted by this Order shall consist of the existing King's Norton, Acock's Green, Balsall Heath, Edgbaston and Smethwick Sub-districts of the King's Norton Registration District; the existing St. Bartholomew Sub-district of the Aston Registration District, and the existing St. Martin's and Sparkbrook Sub-districts of the Birmingham Registration District.

4. The Superintendent Registrar of the existing Birmingham Registration District shall be the Superintendent Registrar of the Birmingham North Registration District.
