WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria. Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared and laid before His Majesty in Council a Representation, bearing date the 31st day of July, 1924, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council the following Representation as to the assignment of a Consolidated Chapelry to the consecrated Church of Saint Thomas the Apostle, Hove, situate within the New Parish (sometime District Chapelry) of Saint Patrick, Hove, in the County of Sussex and in the Diocese of Chichester:

Chichester:

"Whereas at certain extremities of the said New Parish of Saint Patrick, Hove, and of the Parish of Hove, in the said County and Diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such New Parish and Parish:

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said New Parish of Saint Patrick, Hove, and of the said Parish of Hove should be formed into a Consolidated Chapelry for all Ecclesiastical purposes, and that the same should be assigned to the said Church of Saint Thomas the Apostle, Hove, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Winfrid Oldfield, Bishop of Chichester, as such Bishop, and also as the Patron in right of his See, of the Vicarage of

the said New Parish of Saint Patrick, Hove, as well as of the Vicarage of the said Parish of Hove (in testimony whereof he has signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said New Parish of Saint Patrick, Hove, and of the said Parish of Hove, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Thomas the Apostle, Hove, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Thomas, Hove.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem

meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Thomas, Hove, comprising:—

"I. All that portion of the New Parish (sometime District Chapelry) of Saint Patrick, Hove, in the County of Sussex and in the Diocese of Chichester, which is bounded upon the east by the New Parish of All Saints, Brighton, upon the north partly by the New Parish of Saint Luke, Prestonville, and partly by the Consolidated Chapelry of the Good Shepherd, Preston, Brighton, upon the west by the Parish of Hove, all in the said County and Diocese, and upon the remaining side, that is to say, upon the south by an imaginary line commencing upon the boundary which divides the said Parish of Hove from the said New Parish of Saint Patrick, Hove, at the junction of Holland Road with the road called Somerhill Avenue, and extending thence eastward along the middle of Somerhill Avenue for a distance of $7\frac{1}{2}$ chains or thereabouts to its junction with Somerhill Road, and extending thence north along the middle of Somerhill Road for a distance of 41 chains or thereabouts to its junction with the road called Nizell's Avenue, and extending thence south-eastward along the middle of Nizell's Avenue for a distance of 211 chains or thereabouts to its junction with Osmond Road, and extending thence southward along the middle of Osmond Road for a distance of 11 yards or thereabouts to its junction with the road called Windlesham Avenue, and extending thence south-eastward along the middle of Windlesham Avenue for a distance of 11 chains or thereabouts to the point where the boundaries of the said New Parish of Saint Patrick, Hove, the New Parish of Saint Stephen, Brighton, in the said County and Diocese, and the New Parish of All Saints, Brighton, all meet.
