## DANGEROUS DRUGS ACT, 1920. (10 & 11 Geo. 5, c. 46).

Notice is hereby given under the Rules Publication Act, 1893, that the Secretary of State for the Home Department proposes, after the expiration of forty days from this date, to make Regulations under Sections 3 and 7 of the Dangerous Drugs Act, 1920 (10 & 11 Geo. 5, c. 46), amending the Raw Opium Regulations, 1921 (S.R. & O., 1921, No. 864), and the Dangerous Drugs Regulations, 1921 and 1923 (S.R. & O., 1921, No. 865 and S.R. & O., 1923, No. 312).

The effect of the new Regulations is to prohibit the diversion of consignments of raw opium and dangerous drugs passing through ports in Great Britain to destinations different from those to which the consignments were licensed from the country of export; and to modify in the case of prescriptions issued on National Health Insurance forms the requirements to be observed before a prescription for dangerous drugs is dispensed.
