The Civil Service Commissioners hereby give notice that the following amendment of the Special Regulations respecting a Competitive Examination among women for appointment to the Clerical Classes (General and Departmental) of the Civil Service, published in the London Gazette of the 3rd October, 1924, has been approved by the Lords Commissioners of His Majesty's Treasury, viz.:—

Regulation 3, after the words "Established Civil Servants are not eligible to compete" the following words are added, viz.:—

"Provided that exception may be made to this Regulation in the case of those women who entered either the competition for the Clerical Class held in October, 1920, or that held in October, 1922, and who accepted posts as Writing Assistant after failure in one of those competitions provided that they satisfy the requirements in Clause 2 of these Regulations."
