6. This Order shall come into operation on the first day of January, 1925, and shall remain in force until rescinded or modified by the Minister of Transport.

BIRKENHEAD IMPORTED ANIMALS  
WHARF ORDER OF 1924 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

*Definition of Imported Animals Wharf.*

1. The premises described in the Schedule to this Order are hereby defined as an Imported Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1922, and any Order of the Minister thereunder.

*Revocation.*

2. The Birkenhead Imported Animals Wharf Order of 1924 is hereby revoked.

*Commencement.*

3. This Order shall come into operation on the seventeenth day of November, nineteen hundred and twenty-four.

*Short Title.*

4. This Order may be cited as the BIRKENHEAD IMPORTED ANIMALS WHARF ORDER OF 1924 (No. 2).

FOOT-AND-MOUTH DISEASE (INFECTED  
AREAS) ORDER OF 1924 (No. 168).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

*Declaration of Infected Areas.*

1. The Areas described in the Schedule to this Order are hereby declared to be Infected Areas for the purposes of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 164), hereinafter referred to as the "Principal" Order.

*Revocation of Certain Order.*

2. The Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 167) is hereby revoked.

*Commencement*

3. This Order shall come into operation on the twenty-second day of November, nineteen hundred and twenty-four.

*Short Title.*

4. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 168), and shall be read with the Principal Order.
