LIGHT RAILWAYS ACTS 1896 and 1912

DUDLEY AND DISTRICT LIGHT RAILWAYS  
(AMENDMENT).

NOTICE is hereby given that the Dudley Stourbridge and District Electric Traction Company Limited whose registered office is situate at 88, Kingsway in the County of London (hereinafter for themselves their successors and assigns referred to as "the Company") intend to apply to the Minister of Transport for an Order under the Light Railways Acts 1896 and 1912 and the Railways Act 1921.

To authorise the Company to abandon Railways Nos. 1 2 and 3 authorised by the Dudley and District Light Railways Order 1898 or any part or parts thereof and so much of the undertaking authorised by the said Order as relates to the said Railways Nos. 1 2 and 3 in the County Borough of Dudley in the County of Worcester and in the Urban District of Amblecote and the Rural District of Kingswinford in the County of Stafford.

To authorise the Company to discontinue the working of the said Light Railways or any
