SHEFFIELD.

Whereas the Lord Mayor, Aldermen, and Citizens of the City of Sheffield (hereinafter called the Corporation), being the Urban Sanitary Authority for the said City, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend Local Acts as follows:—

(1) (a) Section 43 of the Sheffield Corporation (Consolidation) Act, 1918, and the Sheffield Water (Modification of Charges) (No. 2) Order, 1922, confirmed by the Ministry of Health Provisional Orders (Sheffield Water Charges) Confirmation Act, 1923, so as to empower the Corporation to purchase, and the Wortley Rural District Council to sell the Chapeltown Waterworks Undertaking of the said District Council, and to provide that upon the completion of the said sale and purchase the said Sheffield Water (Modification of Charges) (No. 2) Order, 1922, shall be repealed and cease to have effect.

(b) Sections 416 and 439 of the said Sheffield Corporation (Consolidation) Act, 1918, so as to provide that the City
