THE ROADS ACT, 1920.

COUNTY BOROUGH OF WORCESTER.

Whereas by Sub-section 4 of Section 7 of the Roads Act, 1920, it is enacted that the Minister of Transport may, by order of the application of any County Council (as defined in Section 17 of the Act), after holding a public inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of mechanicallypropelled vehicles of any specified class on any specified highway within the area of the council in any case in which it appears to him, as the result of the inquiry, to be proved that a vehicle of that class cannot be used on that highway without endangering the safety of the vehicle or the persons therein or of other traffic using the highway, or that the highway is unsuitable for use by a vehicle of that class;

And whereas the Council of the County Borough of Worcester have made application to the Minister of Transport for an Order to be made in pursuance of the said Sub-section prohibiting or restricting, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of (a) heavy motor cars and (b)passenger carrying vehicles with a seating
