	In sub-paragraph (<i>cccc</i>) for the words "of which he is the registered proprietor in pursuance of paragraph (c)" there shall be substituted the words "of which he or the Custodian is the registered proprietor"; and at the end of the same sub-paragraph there shall be inserted the words "and as if references to the Custodian in the said sub-sections included references to the Administrator."
	At the end of sub-paragraph (d) there shall be inserted the words "and as if for references to the Custodian there were substituted references to the Administrator."
l (xviia)	After the words "received by him" there shall be inserted "whether in his capacity of Controller or Administrator," and for the words "either of the two last-mentioned Orders" there shall be substituted the words "any of those Orders."

THE UNIVERSITIES OF OXFORD AND CAMBRIDGE Acts, 1877-1923.

The following Statute made by the Chancellor, Masters and Scholars of the University of Cambridge on the 10th day of November, 1924, and the approved by University of Cambridge Commissioners on the 29th day of November, 1924, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923 '':

STATUTE to alter and amend the Statutes in relation to the University of Cambridge, made under "The Universities of Oxford and Cambridge Act, 1877 " (40 and 41 Victoria, Chapter 48), and having been approved by the University of Cambridge Commissioners, under "The Universities of Oxford and Cambridge Act, 1923 " (13 and 14 George V.
Chapter 33), which approval is testified by the Common Seal of the Commissioners being hereunto affixed, which amending Statute is now submitted for the approval of His Majesty The King in Council.

We, the Chancellor, Masters, and Scholars of the University of Cambridge, in pursuance of the power given to us by the 53rd Section of the Universities of Oxford and Cambridge Act, 1877, and by the 11th Section of the Schedule to the Universities of Oxford and Cambridge Act, 1923, do hereby alter and amend the Statutes made under the Universities of Oxford and Cambridge Act, 1877, in relation to our said University in manner following, that is to say:—

By adding to Statute A the following Chapter to follow Chapter I and precede Chapter II:---

" CHAPTER IA. MATRICULATION.

"No person shall be matriculated who has not passed or been exempted from an Examination to be recognised for the purpose by the University, except duly admitted Research Students and other persons or classes of persons whom the Council of the Senate shall have approved for that purpose."

Given under our Common Seal this tenth day of November, one thousand nine hundred and twenty-four.

We, the University of Cambridge Commissioners, acting under the powers conferred on us by the Universities of Oxford and Cambridge Act, 1923, do approve Chapter IA. herein set forth, to be added to Statute A of the Statutes for the University of Cambridge: such Chapter being a Statute wholly for the said University.
