#### URBAN DISTRICT OF MELKSHAM.

**N**OTICE is hereby given that by an Order

 pursuance of Section 112 of the Public Health  
 Act, 1875, as amended by Section 51 of the  
 Public Health Acts Amendment Act, 1907,  
 declaring each of the trades of a Blood-drier,  
 a Tanner, a Leather-dresser a Fat-melter or  
 Fat-extractor, a Glue-maker, a Size-maker, a  
 Gut-scraper, and a Rag and Bone dealer within  
 the Urban District of Melksham to be an  
 offensive trade. A copy of the above-mentioned

#### BOROUGH OF LISKEARD.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

**B**Y an Order dated the 17th day of  
 December, 1924, the Minister of Health  
 has declared that, on and after the 5th day  
 of February, 1925, the following provisions of  
 the Public Health Acts Amendment Act, 1907,  
 shall be in force in the Borough of Liskeard,  
 viz. :—

Part II (streets and buildings) other than  
 Sections 22, 26, 27, 30 and 31;

Part III (sanitary provisions) other than  
 Section 43;

Part IV (infectious diseases) other than  
 Sections 61, 66, 67 and 68; and

Part V (common lodging houses)
