eight days. During the said period the animals shall be kept separate from all other animals, and no other animals shall be moved into such premises.

Now the Agricultural Wages Board in pursuance of the said Act and for the purpose of carrying out the decision of the said Committee, hereby order that the provisions contained in the Schedule to this Order shall become effective from the 26th day of January, 1925.

ORDER DEFINING THE EMPLOYMENT TO BE TREATED AS OVERTIME EMPLOYMENT.

The Berkshire Agricultural Wages Committee, in pursuance of the powers vested in them by the Agricultural Wages (Regulation) Act, 1924, and the Agricultural Wages Committees Regulations, 1924, do by this Order define the undermentioned employment as the employment which is to be treated as overtime employment for the purpose of the application of any differential rate of wages for overtime fixed by the said Committee:—

- (a) All employment in excess of 5 hours (exclusive of meal times) on a Saturday, or on such other day (not being Sunday) in every week as may be agreed between the employer and the worker.
 - (b) All employment on a Sunday.
- (c) All employment in excess of 50 hours in any week (excluding all hours which are to be treated as hours of overtime employment) throughout the year.
