MANCHESTER IMPORTED ANIMALS
WHARF ORDER OF 1925.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Definition of Imported Animals Wharf.

1. The premises described in the Schedule to this Order are hereby defined as an Imported Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1922, and any Order of the Minister thereunder.

Short Title.

2. This Order may be cited as the MANCHESTER IMPORTED ANIMALS WHARF ORDER OF 1925.

Revocation.

3. The Manchester Imported Animals Wharf Order of 1924 (No. 2) is hereby revoked.

FOOT-AND-MOUTH DISEASE (INFECTED
AREAS) ORDER OF 1925 (No. 4).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power

enabling him in this behalf, hereby orders as follows:—

Declaration of further Infected Area.

1. The area described in the Schedule to this Order is hereby declared to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 164), hereinafter referred to as the Principal Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1925 (No. 4), and shall be read with the Principal Order.

Infected Area.

An Area comprising:—

In the county of Sussex.

The county boroughs of Brighton and Eastbourne.

The boroughs of Lewes, Hove and Worthing.

The petty sessional divisions of Steyning (except the parishes of Wiston, Ashington, Washington, Warminghurst, Thakeham, Sullington, and Storrington), Hove, Haywards Heath (except the parishes of Ardingly, Balcombe and Slaugham), Lewes, Uckfield (except the parishes of Hadlow Down and Waldron) and Hailsham (except the parishes of Heathfield, Warbleton, Herstmonceux, Wartling, and Pevensy), and the parishes of Sompting, Durrington, Shermanbury and Cowfold.

INCOME TAX.

Whereas it has become necessary to renew the list of persons to supply vacancies amongst the Commissioners appointed to act in the division of Berkeley Upper, in the county of Gloucester, as Commissioners for the General Purposes of the Acts of Parliament relating to Income Tax and Inhabited House Duties: Now we, two of the Commissioners of Inland Revenue, in pursuance of the powers vested in us in that behalf, do hereby convene a Meeting of the Land Tax Commissioners having jurisdiction with regard to Land Tax within the division aforesaid being respectively qualified to act as such Commissioners, to be holden at the Petty Sessional Court, Dursley, on Monday, the 23rd of February, 1925, at
