ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 24th January, 1925.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts :—

And whereas the Gosport and Alverstoke Urban District Council Act, 1919, provided that the boundaries of the parish of Alverstoke and of the district should be extended as from the date of completion of certain work so as to include in that parish and district a certain portion of the parish of Portsmouth and of the County Borough; And whereas such work has been completed,

And whereas such work has been completed, and it is expedient that a corresponding alteration should be made in the constitution of the Registration Sub-districts hereinafter mentioned :—

Now, therefore, I, Sylvanus Percival Vivian, Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Portsmouth and Alverstoke Registration of Births, &c. (Alteration of Sub-districts) Order, 1925, and shall come into operation on the 1st day of February, 1925.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. That part of Alverstoke Civil Parish which now forms part of the Portsea and Landport Sub-district of the Portsmouth Registration District shall cease to form part of that Sub-district and shall be transferred to and form part of the Alverstoke Sub-district of the Alverstoke Registration District.

4. That part of Alverstoke Civil Parish which now forms part of the Portsmouth and Mid Southsea Sub-district of the Portsmouth Registration District shall cease to form part of that Sub-district and shall be transferred to and form part of the Alverstoke Sub-district.

5. The Superintendent Registrar of the existing Alverstoke Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order. 6. The Registrar of the existing Alverstoke Sub-district shall be the Registrar of that Sub-district as extended by this Order.

NORTHAMPTON GAS.

(Application by the Northampton Gaslight Company for a Special Order under Section 10 of the Gas Regulation Act 1920).

NOTICE is hereby given that the Northampton Gaslight Company (hereinafter called "the Company") whose principal office is at Abington Street, Northampton, intend to apply to the Board of Trade for a Special Order under Section 10 of the Gas Regulation Act 1920 (hereinafter called "the Order") for all or some of the following purposes (that is to say):—

To extend the limits within which the Company are authorised to supply gas and to authorise the Company to supply gas within the Parishes of Great Creaton, Hanging Houghton, Hannington, Holcot, Lamport, Old, Scaldwell, and Walgrave in the Rural District of Brixworth, the Parishes of Floore, and Weedon Beck in the Rural District of Daventry, the Parishes of Bugbrooke, Nether Hey-ford and Upper Heyford in the Rural District of Northampton, the Parishes of Easton Neston with Hulcote, Gayton and Tiffield in the Rural District of Towcester, the Parishes of Brafieldon-the-Green, Cogenhoe, Hackleton, Horton and Piddington and such parts of the Parishes of Preston-Deanery and Quinton in the Rural District of Hardingstone as are not already included in the Company's existing limits of supply and the Parish of Sywell in the Rural District of Wellingborough, all in the County of Northampton; and to authorise the Com-pany within such extended limits to exercise all or any of the rights powers and privileges which they now may exercise within their existing limits of supply; and to make applicable to such extended limits any of the provisions of the Acts or Orders relating to the Company and of the Order.

To enable the Company to continue maintain and use any mains pipes and other works belonging to them at the commencement of the Order within the said parishes as if the same had been laid down or constructed under the powers of the Order.

To make further provision as to the powers of the Company to purchase and sell gas in bulk, to repeal Section 35 of the Northampton Gas Order, 1904, and to amend the obligations of the Company to supply gas in cases where the capacity of mains is insufficient.

To make provision as to the closing of transfer books, the voting by joint holders of shares or stock, and the authentication and service of notices by the Company.

To vary and extinguish all rights and privileges which would interfere with the objects
