ELECTRICITY (SUPPLY) ACTS 1882 TO 1922.

AVON VALLEY ELECTRICITY SPECIAL ORDER.

NOTICE is hereby given that the Shropshire Worcestershire and Staffordshire Electric Power Company whose principal office is situate at 88, Kingsway in the County of London (hereinafter called "the Company") have applied to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1922 for a Special Order (hereinafter called "the Order") for all or some of the following amongst other purposes (that is to say):—
