

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty, Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned Grant to the Incumbent of the Rectory of Castleford in the County and in the Diocese of York one yearly sum or stipend of twenty-one pounds five shillings and fourpence, such yearly sum or stipend to be payable out of the Common Fund under our control, to be calculated as from the fourth day of October in the year One thousand nine hundred and twenty-three and to cease on and from the date of the avoidance of the said Rectory of Castleford by the Reverend Canon William Arthur Steains Hewett.

In witness whereof we have hereunto fixed our Common Seal this fifth day of February in the year One thousand nine hundred and twenty-five.
