ORDER DEFINING THE BENEFITS OR ADVANTAGES WHICH MAY BE RECKONED AS PAYMENT OF WAGES IN LIEU OF PAYMENT IN CASH.

The Holland Agricultural Wages Committee. in pursuance of the powers vested in them by the Agricultural Wages (Regulation) Act, 1924, and the Agricultural Wages Committees Regulations, 1924, do by this Order define the following benefits or advantages (not being benefits or advantages prohibited by law) as the benefits or advantages which may be reckoned as payment of wages in lieu of payment in cash for the purpose of the application of any minimum rate of wages fixed by the said Committee and the values at which they may be so reckoned in the area comprising the administrative County of the Parts of Holland Division of Lincolnshire:

## Benefits or Advantages:—

(a) Milk.

(b) Potatoes.

(c) Lodging, except in any case in which the above Committee shall determine that the lodging accommodation is so defective as to be injurious to health.

(d) Board, including any meals, but not including intoxicating drink.

(e) A cottage, including any garden hitherto given or let with the cottage, except where the cottage is one in regard to which the Medical Officer of Health has reported that it is in a state so dangerous or injurious to health as to be unfit for human habitation.

## 2. Values:-

(a) Milk—the current producer's whole-

sale price prevailing in the district.

(b) Potatoes—the wholesale price prevailing in the district on November 1st in the year preceding that in which the price of potatoes is being reckoned as payment of wages in lieu of payment in cash.

(c) and (d) Lodging and board as above defined for:-

Workers of 18 years and over Per under 18 14 17 73 week 12 > 17 16 " ,, of 16 10 15 ,, " " 7 days. 9) 14 15

(e) Cottage—3s. per week, less any rates which may be paid by the occupier.

3. Provided that in the case of a contract of employment already running at the date when this Order comes into operation 4s. per week may be reckoned as the value of 20 stone of pork in the course of a year.

4. In pursuance of their said powers the said Committee hereby order that except as in this Order provided no benefit or advantage shall be reckoned as payment of wages in lieu of

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (DATED 20TH FEBRUARY, 1925.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1925 (No. 10).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:-

## Declaration of further Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 164), hereinafter referred to as the Principal Order.

Short Title.

2. This Order may be cited as the FOOT-AND-Mouth Disease (Infected Areas) Order of 1925 (No. 10), and shall be read with the Principal Order.
