FOOT- AND - MOUTH DISEASE (IN-
FECTED AREAS) ORDER OF 1925
(No. 11).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Declaration of Further Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 164) hereinafter referred to as the Principal Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1925 (No. 11), and shall be read with the Principal Order.

SCHEDULE.

Infected Area.

An Area comprising:—

In the county of Warwick.

The Cities of Birmingham and Coventry.

The Boroughs of Nuneaton and Sutton Coldfield.

The petty sessional divisions of Wilnecote, Atherstone, Nuneaton (*except the parishes of Stretton Baskerville, Burton Hastings and Wolvey*), Coventry (*except the parishes of Copston Magna, Withybrook, Shilton, Ansty, Combeields, Binley, Willenhall, Brandon, Bretford, Ryton on Dunsmore and Baginton*), Coleshill, Solihull and Henley in Arden (*except the parishes of Oldberrow, Wootton Wawen, Claverdon, Langley and Bearley*), and the parishes of Kenilworth, Wroxall, Honiley, Beausale, Haseley, Shrewley and Hatton.

In the county of Leicester.

The parishes of Higham on the Hill, Fenny Drayton, Atterton, Upton, Witherley, Ratcliffe Culey, Sibson, Sheepy Parva, Sheepy Magna, Twycross, Orton on the Hill and Norton Juxta Twycross.

In the county of Stafford.

The County Boroughs of Smethwick, Walsall, and West Bromwich.

The Boroughs of Wednesbury, Lichfield and Tamworth.

The petty sessional divisions of Tamworth, Lichfield and Brownhills, Rushall, Dudley, Bilston (*except the parish of Sedgely*), Rowley Regis, Wednesbury and Tipton, and the parishes of Norton Canes, Great Wyrley, Essington, Wednesfield, Short Heath, Bentley, Willenhall, Brierley Hill and Quarry Bank.

In the county of Worcester.

The County Borough of Dudley.

The petty sessional division of Halesowen and Oldbury, and the parishes of Dudley Castle Hill, Cradley, Cofton Hackett, Alvechurch, Wythall and Beoley.

ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 21ST FEBRUARY, 1925.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

*Authorisation of Landing of Animals for
Exceptional Purposes.*

1. The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes is hereby allowed, subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the detention of the animals described in the First Schedule hereto.

Examination before Landing.

3. No such animals as aforesaid shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animals have been examined by a Veterinary Inspector of the Ministry, and certified by him to be free from symptoms of contagious disease.

*Regulation Applicable to the Animals on
Landing.*

4. The animals, on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days.
