" 4. By adding to Part II of the said Schedule:—

' Barium, Salts of, except Barium Sulphate.'

" 5. By omitting from Part II of the said Schedule the words:—

' All preparations or admixtures which are not included in Part I of this Schedule and contain a poison within the meaning of the Pharmacy Acts except preparations or admixtures the exclusion of which from this Schedule is indicated by the words therein relating to carbolic acid, chloroform, and coca, and such substances as come within the provisions of Section 5 of this Act,'

and by substituting therefor the words:—

' All preparations or admixtures which are not included in Part I of this Schedule and contain a poison within the meaning of the Pharmacy Acts, except Tobacco prepared for smoking and snuff, machine-spread lead plasters, preparations or admixtures the exclusion of which from this Schedule is indicated by the words therein relating to carbolic acid and chloroform, and except such substances as come within the provisions of Section 5 of the Poisons and Pharmacy Act, 1908.' "
