by or on behalf of a worker, have certified that by reason of inadequate accommodation, want of repair or sanitation or lack of water supply the value of such cottage is less than 3s. the value shall be such sum less than 3s. as the Committee shall determine on a consideration of the defects.

(2) In the case of a cottage with regard to which the Committee, on an application by or on behalf of an employer, have certified that by reason of the cottage having 3 or more bedrooms, combined with other satisfactory accommodation, the value of such cottage is higher than 3s. the value shall be such sum greater than 3s. as the Committee shall determine on a consideration of the accommodation.
