WIRELESS TELEGRAPHY.

THE MERCHANT SHIPPING (WIRELESS TELE-GRAPHY) RULES AMENDMENT RULES, 1925, DATED 21ST APPIL, 1925, MADE BY THE BOARD OF TRADE UNDER THE MERCHANT SHIPPING (WIRELESS TELEGRAPHY) ACT, 1919 (9 & 10 GEO. 5, c. 38).

The Board of Trade in pursuance of the powers conferred upon them by sub-section (2) of Section 1 of the Merchant Shipping (Wireless Telegraphy) Act, 1919, and of all other powers enabling them in that behalf after consultation with the Postmaster-General hereby make the following rules:—

1. These rules may be cited as the Merchant Shipping (Wireless Telegraphy) Rules Amendment Rules, 1925, and shall come into force on the first day of July, 1925.

2. In paragraphs (ii) and (iii) of Article 10 (2) of the Merchant Shipping (Wireless Telegraphy) Statutory Rules dated the 10th July, 1920 (S.R. & O. 1920, No. 976) the words "six months' experience" shall be substituted for the words "one year's experience."
