

as overtime employment for the purpose of the application of any differential rate of wages for overtime fixed by the said Committee for the area comprising the administrative county of Hereford and hereby order that such employment shall be as follows:—

1. In the case of male workers of 21 years of age and over employed wholly or mainly as Bailiffs, Waggoners, Stockmen or Shepherds, all employment in excess of 60 hours in any week (including Sunday).

2. In the case of all other male workers:—

(a) All employment in excess of 6½ hours on a Saturday or on such other day (not being Sunday) in every week as may be agreed between the employer and worker.

(b) All employment on a Sunday.

(c) All employment in excess of 54 hours in any week (excluding all hours which are treated as hours of overtime employment) in Summer.

(d) All employment in excess of 48 hours in any week (excluding all hours which are treated as hours of overtime employment) in Winter.

3. For the purpose of this Order employment in Winter shall be deemed to be employment during the months of November, December, January and February, and employment in Summer shall be deemed to be employment during the rest of the year.

4. This Order shall come into operation on 1st May, 1925.
