In the Parish of Chardstock in the Rural District of Axminster-

3. To authorise the Undertakers to break up in the area of supply the following streets and parts of streets not repairable by a local authority (including roadways over bridges and the approaches thereto):-

(c) Roadways and Footpaths on and approaches to the bridges carrying the following roads over the Railway of the Southern Railway Company:
