## INDIAN CIVIL SERVICE.

In conformity with the provisions of Section I of the Statute, 56 & 57 Victoria, Chapter 66, notice is hereby given that the Secretary of State for India in Council with the advice and assistance of the Civil Service Commissioners proposes at the expiration of 40 days from the date of this Gazette, to make, in pursuance of the powers conferred on him by Section 97 (1) of the Government of India Act, the alterations shown below in the Regulations for competitive examinations in India for appointments in the Indian Civil Service.
