

within a period to be specified by the Order are as follows:—

In the Urban District of Tarporley:—

High Street from the junction of Road Street, and Utkinton Road to Alpha Cottages; Bowmere Road from High Street to Bowmere Lodge; Forest Road from High Street to the footpath leading to Victoria Street.

In the Rural District of Tarvin:—

In the parish of Ashton:—

From Ashton School to Kelsall Road.

So much of Kelsall Road as lies between Manor Farm Ashton, and Ashton Hall Farm.

In the Parish of Churton-by-Aldford:—

Chester Road from Lodge of Churton Lodge to Churton Hall; Hob Lane from junction with Knowl Lane to Church House Farm.

In the parish of Churton-by-Farndon:—

Chester Road from Hob Lane towards Farndon for a distance of seven hundred and fifty feet.

In the Parish of Farndon:—

Chester Road from Oak Cottage to Farndon; High Street, Farndon, from "Dee Bank," Farndon to the junction of Nantwich Road and the road leading to "Rose Villa."

In the parish of Kelsall:—

From "East View" Chester Road to the Kelsall School.

From Chester Road to the junction of Willington Road and Common Lane.

The Old Road from Chester Road to the Parish Boundary.

In the Parish of Mouldsworth:—

Mouldsworth Road from Station Hotel to the Parish Boundary.

Smithy Lane from Mouldsworth Road to the Smithy.

8. To authorise the Corporation to open and break up in the added areas the following streets and parts of streets which are not repairable by the local authority (namely):—

In the Rural District of Tarvin:—

In the parish of Beeston:—

The roadway on and approaches to the bridge carrying the road from Ford Lane to Grimes Lane over the London Midland and Scottish Railway; the roadway on and approaches to the bridge carrying the road from Horton's Mill to Beeston Castle over the London Midland and Scottish Railway; the roadway under the bridge carrying the London Midland and Scottish Railway over the road from Beeston Brook Bridge to Beeston Castle Inn at Beeston Station.

In the parish of Broxton:—

The roadway on and approaches to the bridge carrying the road from Broxton Bridge to Broxton Police Station over the London Midland and Scottish Railway at Broxton Station; the roadway on and approaches to the bridge carrying the road from Fox House to Carden Marsh over the London Midland and Scottish Railway; the roadway under the bridge carrying the

London Midland and Scottish Railway over the road from Chester Road to Lower Farm.

In the parish of Chowley:—

The roadway under the bridge carrying the London Midland and Scottish Railway over the road from Chowley to Dog Lane; the roadway under the bridge carrying the London Midland and Scottish Railway over the road from Chowley to Holywell Farm.

In the parish of Golborn Bellow:—

The roadway on and approaches to the bridge carrying the road from Gates Heath to Princes Farm over the London Midland and Scottish Railway; the roadway under the bridge carrying the London Midland and Scottish Railway over the road from Gates Heath to Brook House.

In the parish of Handley:—

The roadway under the bridge carrying the London Midland and Scottish Railway over the road from Handley to Chowley Oak Cottages.

In the parish of Hatton:—

The roadway on and approaches to the bridge carrying the road from Miller's Heath to Hatton Farm over the London Midland and Scottish Railway; the roadway on and approaches to the bridge carrying the road from Long Lane to Hatton Farm over the London Midland and Scottish Railway; the roadways on and approaches to the two bridges carrying the road from Long Lane to Hatton Hall over the London Midland and Scottish Railway.

In the parish of Mouldsworth:—

The roadway on and approaches to the bridge carrying the road from Old Quarry to Station Hotel over the London and North Eastern Railway (Great Central Section); the roadway on and approaches to the bridge carrying the road from Mouldsworth to Mouldsworth Hall over the London and North Eastern Railway (Great Central Section); the roadway on and approaches to the bridge carrying the road from Mouldsworth Hall to Rookery Farm over the London and North Eastern Railway (Great Central Section); the roadway under the bridge carrying the London and North Eastern Railway (Great Central Section) over the road from Mouldsworth to Brines Brow; the roadway under the bridge carrying the London and North Eastern Railway (Great Central Section) over the road from Stone House to Ashton.

In the parish of Newton-by-Tattenhall:—
