To confer upon the Corporation all, or some, of the powers of the Electricity (Supply) Acts, 1882 to 1922, and the enactments incorporated therewith and to alter, vary, or extinguish all rights and privileges which would, or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for carrying such objects into effect.
