BOROUGH OF WAREHAM.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the seventeenth day of August, 1925, the Minister of Health has declared that, on and after the 5th day of October, 1925, the following provisions of the Public Health Acts Amendment Act 1907 shall be in force in the Borough of Wareham, namely:—

Part II (Streets and Buildings) other than Section 27; Part III (Sanitary Provisions) other than Sections 39 to 42 (inclusive); Part IV (Infectious Diseases); Part V (Common Lodging houses); Part VI (Recreation Grounds); and Part X (Miscellaneous provisions).

The above provisions are declared to be in force subject as regards Sections 23, 25, 30, 35, 38, 75 and 92 to the conditions specified in the Order.

A copy of the Order may be inspected at the Town Clerk's Office, Wareham, between the hours of 10 a.m. and 4 p.m. on any week-day other than Saturdays during the period from August 29th to October 5th, 1925, both inclusive.

BLACKBURN, BURNLEY AND CLITHEROE RURAL
DISTRICTS ELECTRICITY SPECIAL ORDER, 1925.
