1. The area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

Commencement and Short Title.

2. This Order shall take immediate effect and may be cited as the DORSETSHIRE FOOT-AND-MOUTH DISEASE INFECTED AREA ORDER OF 1925.
