Venice, July 13. N. S.

**T**HE Senate have made Choice of the Chevalier *Pietro Venier*, at present Ambassador from this Republick at *Madrid*, to go to the Court at *Vienna* with the same Character. A Vessel is arrived here, who departed from *Napoli di Romania* the 26th of *May*, and brings advice, That the Convoy which sailed hence under the Command of Signior *Borvicino*, was arrived there, and that the Captain-General intended in few days to put to Sea with the Venetian Fleet. Several *Moscovites* are come hither, some intend to go to the Venetian Army in the *Levant*, to serve as Volunteers, and others to Study Navigation here, which must be look'd upon as an Effect of their present Czar's Military Disposition, and desire of knowing what passes in other Countries, seeing heretofore the *Moscovites* were never permitted to Travel abroad, except on Embassies.

*Warsaw*, July 16. Some of the Principal Senators and Deputies of the *Dyets* have had several Meetings together, to endeavour to Reconcile the two Parties, but on the 11th Instant these Conferences ended, without any Agreement. The Saxon Party are going to Print a *Manifesto*, to let the World see that the Election of the Elector was made according to the usual Forms, and Laws of the Republick; The French on the other side pretend he was not duly Chosen, because it was not by a General Acclamation and Consent of the Genry, as they say the Constitution of the Kingdom requires; and they endeavour to come to a new Election, to which end the Primate has Summoned another *Dyets* to meet the 18th of the next Month, the Circular Letters for this purpose being Signed by himself, the Archbishop of *Leopol*, the Bishop of *Plaska*, two other Bishops, *Sapias* General of *Lithuania*, *Lubomirski* the Crown-General, and some others who would be thought to be Neuters; but the rest of the Senators and Officers of State, being much the greater number, are resolv'd to maintain the Election of the Elector of *Saxony*, and on Sunday last in the Morning they met in the Cathedral Church of this City, where the *Pacta Conventa*, or Capitulation with the New King, were in his Name Sign'd and Sworn to by Monsieur *Fleming* his Ambassador; and some of the Deputies of the late *Dyets* began to protest against this Proceeding, but were soon silenced. Since this the Ambassadors that are to attend the Elector of *Saxony*, have begun their Journey to *Tarnowitz* in the Frontiers of *Silisia*, where he expects them; and Preparations are made for his Coronation at *Warsaw*, on the 15th of *September*. In the mean time the French Ambassador continues to distribute great Sums of Money, and libours particularly to get the Army to Confederare, but without Effect, they having declin'd for the Elector of *Saxony*, who has sent them 100000 Crowns towards Payment of their Arrears. The French Ambassador to support his Party, has underhand caus'd it to be spread about, That 40000 Turks and Tarrars are marching towards the Frontiers of this Kingdom, and that 20000 Hungarians commanded by Count *Teckley* are likewise moving that way; but these Menaces make little Impression upon People, and so much the less, because the Elector of *Saxony* has 4000 Horse and 6000 Foot of his own Forces on our Frontiers; the Elector of *Brandenburgh* has likewise a good Body of Troops ready in *Prussia*, and the Czar of *Moscovy* has declared, That if there be occasion, he will cause 60000 Men to march into *Poland*, to oppose the Prince of *Crowi*, and those in his Interests.

*Vienna*, July 17. About three weeks ago we had the first account that a great many Hungarians were assembled together in Arms, and had surprized and cut in Pieces the German Soldiers that were in Garrison at *Tockay*, and two other small places in *Upper-Hungary*; We understood afterwards that they had published a kind of a Declaration in the Name of Count *Teckley*, to encourage others to follow their Example, and join with them; Hereupon some of the Emperor's Forces quartered in that Country were order'd out to suppress them; On the 7th Instant a Detachment of 600 Horse of the Regiment of *Bassompierre*, and two Squadrons of Hussars, commanded by Colonel *le Brun*, came up with the Rebels, who were

about 2000 Foot and 500 Horse, near *Onoth*, and after a Dispute of several hours, routed them, the greatest part being killed, or taken, with several Colours; and of the Germans about 60 were killed and wounded, and among the former were two Captains of Horse. Two days afterwards Colonel *Dyacke* having with him 1000 *Heddukes*, met and detac'd another Body of the Hungarian Rebels, and cut off 400 of them; since which their other Parties (for in all they are said to have been about 10000, tho' many of them without Arms) are disperfed; and it is believ'd *Tockay* will submit to the first of the Emperor's Troops that appear before the Place; However several German Regiments are marching towards *Upper-Hungary*, to secure the Quiet of those Parts; and the Emperor has caus'd a Reward of 1000 Crowns to be offer'd for each of the Principal Rebels, that shall be put into the Hands of any of his Officers. It being resolv'd to raise the Siege of *Bihatz*, the Count *d'Avrersberg* sent away the Artillery on the 4th and 5th Instant, and on the 7th all the Forces march'd from thence to join the Imperial Army near *Baya*. We do not yet hear that the Turkish Forces are drawn together in any considerable Body on our Frontiers; or that the Grand Signior is come farther than *Philippoli*.

*Frankfort*, July 25. The French Army commanded by *Marschal de Choufful*, retired several days ago from *Rastatt* to the Camp, where they are at present, near *Fort-Louis*, and their Intention seems to be to repair the *Rhine*. Prince *Lewis* with the Confederate Army lies still at *Mackensburne*; Several German Parties sent from thence, have had good Success against the Enemy, of whom 'tis reckon'd they have cut off 400 within these few days.

*Hamburgh*, July 26. We have an account from *Dresden*, that two Gentlemen of the Elector of *Saxony's* Court arriv'd there the 20th of this Month, having left the new King at *Tarnowitz*, on the Frontiers of *Silisia*; who 'twas said had been privately at *Cracow*, about 12 Miles from thence, and had a meeting with the Bishop of that Place. The Elector has again assur'd his Council at *Dresden*, That he will do nothing contrary to the Laws and Established Religion, in *Saxony*, and desires those that report he has any other Intention, may be strictly enquired after and punished.

*Paris*, July 26. On the 22th Instant arriv'd here an Express from the Duke de *Vendosme*, giving an account of his having surprized the Spanish Troops in their Camps not far from *Barcelona*; The Particulars, as the French relate them, are as follow; The Marquis de *Grigny* lay with 2500 Spanish Horse at *Cornelle*, a Village about a League from the Right of our Camp; Don *Michel d'Oranzo* was posted on the Hills behind our Camp with 600 Horse, 1000 Foot, and 3 or 4000 *Sommetans*; The Horse under the Marquis de *Grigny* had by means of the Fort called the *Montjoye*, a free Communication with the Town, and facilitated the Passage of the Convoys sent thither with Ammunition and Provisions; The Enemy had resolv'd that on the 14th at night the Garrison should make a general Sally on our Trenches, and at the same time the Marquis de *Grigny*, and Don *Oranzo* should attack our Camp; The Duke de *Vendosme* having notice hereof, detached 2200 Horse and 3000 Foot, and march'd with them the 13th before day towards *Cornelle*, and at the same time commanded Lieutenant-General *d'Uffen* with 2000 Fuseliers and Grenadiers, and 1000 Horse towards the Hills, Lieutenant-General *Barbezieres* remaining in the Camp with the rest of the Forces, to maintain the Guard of the Trenches, and observe the Garrison; Monsieur de *Legal*, who commanded the Vanguard of the Troops that were with the Duke de *Vendosme*, being come near to the Village of *Cornelle*, met 4 or 5 Troops of the Enemies Horse, who being forced to retire, the French follow'd them so close, that they entred with them into the Spanish Camp, and the rest of our Forces immediately after them; The Enemy had not time to defend themselves, and the French went on to the Village of *St. Ellice*, the Quarters of the Viceroy, who escap'd with much difficulty; The French Soldiers fell to Plundering, and among other things took a Box wherein were 2000 Pistoles; in the mean time the Spanish Horse rais'd, and 3 or 4 Squadrons came

came and attacked our Horse who were dispersed, and killed many of them, but these being supported by some fresh French Squadrons, stop'd the Enemy; The Duke de Vendosme not thinking fit to proceed farther, burnt what he could not bring away, and then retired to his Camp: Whilst this was doing Lieutenant-General d'Usson attack'd the Enemy on the other side, and came upon them so unexpectedly, that several Officers were killed in their Beds; The Spaniards here lay in 3 several Camps, or Posts; two they quitted in the first Disorder, but maintained the third; and when our Troops retired, part of their Horse came on and charged our Carabiniers, and at the same time several others of the Enemies Squadrons appeared, to intercept our Foot coming down from the Hills, but the care of Monsieur de Barbezieres in sending some Troops from the Camp to support us, prevented the Enemies design, and we made our Retreat, without any considerable Loss; In both these Actions the Spaniards, by computation, lost 6 or 700 Men, and the French pretend to have lost but 150; and that they took 100 Prisoners, and 6 or 700 Horses and Mules. Before this News came, they were in great Pain at the French Court for the Success of the Siege, and whether they have not reason to be so still the next Letters will inform us; For the Spaniards being, as these advices say, repossessed of the Camp at *Cornille*, and their loss in the late Actions inconsiderable, they have it still in their Power to apply the Town with what they want, and consequently the Garrison are in as good Condition as they were before it, to defend it. 'Tis very much wonder'd that we hear nothing all this while concerning *Pointy's* Expedition to the *West-Indies*; and People are apt to believe that there must be advices come from him, but that not being very good, they are kept secret. There is little said here at present concerning the Prince of *Conte's* Pretension to the Crown of *Poland*; The best they hope for, is, that the Poles will go to a new Election; tho' by the fresh Letters there is but little likelihood of it.

From His Majesty's Camp at *Cockleberg*, July 29. On Friday last there was a 4th Conference between the Earl of *Portland* and *Marschal Boufflers*, near *Hall*; They were attended by above 50 Officers of the Army, who entertained each other with great Civility; The two Generals, after they had been some time in the Field, went into a House in the Suburbs of *Hall*, where they had Pen, Ink and Paper, and were together for an hour longer. His Majesty has taken a Review of the English Foot, and found them compleat and in very good Order; and on Saturday His Majesty began the Review of the Dutch Foot. The same day the French marched towards *Alost* for the Convenience of Forage; and His Majesty has thereupon sent a Body of Foot and Dragoons, with 10 Field Pieces, to secure the Pass at *Burnt-Bridge*. *Marschal Villerois's* Camp is at *Afflegem*; *Marschal Boufflers* about a League on this side *Dendermonde*; and *Marschal Gatinat* lies behind the Lines. 'Tis said His Majesty will leave the Army in few days, and the Troop of Dutch Guards marched yesterday towards *Breda*, to attend His Majesty in his way thither.

*Hague*, July 30. N. S. 'Tis believed the Impartial Ambassadors will give in their Answer to the French Project of Peace, to-morrow at the Conference at *Ryswick*; the rest of the Allies are likewise preparing their Answers, and may have them ready in a day or two. The King is expected at *Log* the next week. On Sunday last *Don Quior*, One of the Spanish Plenipotentiaries gave the French Ambassadors a very Noble Entertainment.

*Falmouth*, July 22. This Evening came in here a Flushing Privateer, called the *Anna-Jacoba*, Capt. *Wills* Commander, from Cruising in the Bay of *Biscay*, where he took 3 Prizes, one laden with Wine, another with Pitch, Tar and Rosin, and the third a Privateer of 8 Guns, and sent them all to *St. Antonia*.

*Biddisford*, July 24. This Evening arrived here the *Seanderberg* from *Barbadoes*; whence she departed about 5 weeks ago in Company of 40 sail; The Master says, 'twas reported before he came away, that Vice-Admiral *Nevill* had fallen in with *du Pointy*, and had taken and sunk several of his Ships, but they expected it's Confirmation.

*Plimouth*, July 25. The 21th Instant came in here His Majesty's Ship the *Rye*, and *German* Advice-Boat, and brought with them a French Privateer of 16 Guns and 103 Men, taken two days before. The Fleet under the Command of Sir *George Rooke* passed by this Place the 22th, and arriv'd the same day in *Torbay*. Yesterday came in here the *Content* and *Dorsetshire* with two hundred men from *Bourdeaux*, and a French Prize bound home from *Newfoundland*.

*Portsmouth*, July 25. On the 23d Instant Lieutenant-Admiral *Alemard* arriv'd at *Spithead* with two Dutch Men of War and a Fire-ship from the Fleet, and he is since come ashore and gone for *London*.

*Deal*, July 25. This Morning Rear-Admiral *Bendow* in His Majesty's Ship *Norfolk* pass'd by the South-Sand-Head, to command the Squadron before *Dunkirk*.

*Whitehall*, July 27. This day *John Povey Esq.* was Sworn Clerk of His Majesty's most Honourable Privy-Council in Ordinary, in the Place of *Richard Cooling Esq.* deceased; and at the same time *James Vernon Junior Esq.* was Sworn Clerk of the Council in Extraordinary.
