OF APPOINTMENT STANDING FOR FOUR HACKNEY CARRIAGES.

By virtue of the Act 13 and 14 Victoria, Chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other Pro-visions in regard to the Consolidated Offices."

THOMAS FRANCIS WILLIAM HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Four Hackney Carriages at Princes Street, Oxford Street, W., and do make the following Regulations with regard to the Boundaries for the same, viz. :-

In centre of roadway, commencing 13 feet North of the refuge at its junction with Oxford Street, and extending Northward as far as necessary for four carriages.

Front of vehicles towards the South.

Provided that no Hackney Carriage shall be suffered to stand across any Street or Thoroughfare, or opposite the end of any Street or Carriageway, or upon any place where Foot Passengers usually cross the Carriageway.

BOOT AND SHOE REPAIRING TRADE BOARD (GREAT BRITAIN).

PROPOSAL (1) TO VARY GENERAL MINIMUM TIME RATES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS; AND (2) TO FIX AND TO VARY CERTAIN GENERAL MINIMUM PIECE RATES FOR MALE AND FEMALE WORKERS; AND (3) TO VARY THE OVERTIME RATES FOR ALL MALE AND FEMALE WORKERS; FOR PERIODS DEPENDENT UPON THE "COST OF LIVING "FIGURE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated respectively 31st October, 1918, and 1st August, 1922, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain, for the branches of trade specified in the Trade Boards (Boot and Shoe Repairing) Order, 1919, HÈREBY GIVE NOTICE that they PROPOSE TO VARY the General Minimum Time Rates for certain classes of Male Workers in their application to Workers under 21 years of age, other than Apprentices and Learners of the classes specified in the Trade Board's Notices D. (29) and D. (24) respec-tively, and in their application to certain classes of Male Apprentices commencing their apprenticeship at 18 years of age or over, and the General Minimum Time Rates for Male and Female Learners, AND TO FIX AND TO

VARY certain General Minimum Piece Rates for Male and Female Workers, AND TO VARY the Overtime Rates applicable to all Male and Female Workers, the proposed rates to be operative for periods dependent upon the "Cost of Living" figure. The Minister of Labour has given his

consent, in so far as such consent is required, to the issue of the Notice of Proposal.

Information in respect of the Trade Board's Proposal may be obtained on application to the Secretary of the Trade Board at the address given below.

The Trade Board will consider any OBJEC-TIONS to the above Proposal which may be lodged with them within two months from the 20th day of November, 1925. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Boot and Shoe Repairing Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that the objections should state precisely, and, so far as possible, with reasons, what is objected to.
