the Company the Kidderminster & District Electric Lighting & Traction Company Limited and the Mayor Aldermen and Burgesses of the Borough of Kidderminster relating to various matters including the abandonment or discontinuance of a tramway and the postponement of the rights of the said Mayor Aldermen and Burgesses to purchase compulsorily part of the undertaking of the Company; to increase the borrowing powers of the Company and to authorise them to issue redeemable debenture stock.

1. To authorise the Company to provide and run vehicles propelled on roads by mechanical power conveyed by overhead wires and trolleys (in this Notice called "trolley vehicles") on the following additional routes:—
