

bridge which carries the main line of the London Brighton and South Coast Section of the Southern Railway across Purley Downs Road, and extending thence south westward along the middle of Purley Downs Road for a distance of  $7\frac{1}{2}$  chains or thereabouts to its junction with the road called Purleybury Avenue, and extending thence south westward along the middle of Purleybury Avenue for a distance of  $2\frac{1}{2}$  chains or thereabouts to a point opposite to the wall or fence on the southern side of the avenue leading to the house and premises known as Purleybury, and extending thence south eastward to and along the said wall or fence for a distance of 2 chains or thereabouts to the point where it meets the wall or fence forming the north western boundary of the premises attached to the said house, and extending thence south westward along the last mentioned wall or fence for a distance of  $2\frac{1}{2}$  chains or thereabouts to the point where such wall or fence meets the wall or fence forming the south western boundary of the said premises, and extending thence first south eastward, then south westward and then again south eastward along the last mentioned wall or fence for a distance of 9 chains or thereabouts to the point where it meets the fence forming the western boundary of the Purley Downs Golf Course, and extending thence first south westward and then southward along the last mentioned fence which in part forms the eastern boundary of the houses and premises situate on the eastern side of Brancaster Lane, for a distance of  $16\frac{1}{2}$  chains or thereabouts to the point where it meets the fence forming the southern boundary of the Purleybury Building Estate, and extending thence eastward and in a straight line (thereby crossing the Croydon, Oxted and East Grinstead line of the Southern Railway and the Purley Downs Golf Course) for a distance of 34 chains or thereabouts to a point on the north eastern side of Purley Downs Road in the middle of the footpath which runs past the south eastern side of the houses and premises known as Hill Barn into Purley Oaks Road, and extending thence first north eastward, then north westward and then again north eastward along the middle of the said footpath for a distance of  $18\frac{1}{2}$  chains or thereabouts to its junction with Purley Oaks Road and the footpath leading from that road into Sanderstead Road, and extending thence north eastward along the middle of the last mentioned footpath for a distance of  $3\frac{1}{2}$  chains or thereabouts to its junction with Sanderstead Road, and extending thence north westward along the middle of Sanderstead Road for a distance of  $4\frac{1}{2}$  chains or thereabouts to its junction with the roadway leading into the road called Hook Hill, and extending thence north eastward along the middle of such roadway for a distance of  $8\frac{1}{2}$  chains or thereabouts to its junction with Hook Hill, and extending thence north eastward along the middle of Hook Hill for a distance of  $5\frac{1}{2}$  chains or thereabouts to its junction with the road called The Ridgeway, and continuing thence north eastward in precisely the same direction and in a straight line for a distance of 22 chains or thereabouts to a point in the middle of the bridle road leading from Arkwright Road into Selsdon Road, and extending thence first north westward and then north eastward along the middle of the

said bridle road for a distance of 22 chains or thereabouts to its junction with Selsdon Road, and extending thence north westward along the middle of Selsdon Road for a distance of  $12\frac{1}{2}$  chains or thereabouts to the boundary which divides the said Parish of Sanderstead from the said New Parish of Emmanuel, South Croydon.

" II. And also all that contiguous portion of the said New Parish of Saint Augustine, Croydon, which is bounded upon part of the south by the said New Parish of Christ Church, Purley, upon the remaining part of the south and upon the east by the above described portion of the said Parish of Sanderstead, and upon the remaining sides, that is to say, upon the north and upon the north west, by an imaginary line commencing at the point in the middle of the said Croydon, Oxted and East Grinstead line of the Southern Railway where the boundaries of the said Parish of Sanderstead, the said New Parish of Emmanuel, South Croydon, and the said New Parish of Saint Augustine, Croydon, all meet and where the boundary which divides the County Borough of Croydon from the Civil Parish of Sanderstead crosses the middle of such line of railway, and extending thence first north westward and then south westward along the last mentioned boundary for a distance of  $58\frac{1}{2}$  chains or thereabouts to the boundary which divides the said New Parish of Saint Augustine, Croydon, from the said New Parish of Christ Church, Purley."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly herein-before mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark and by the Registrar of the said Diocese of Canterbury.
