Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the New Parish (sometime Particular District) of Saint John the Evangelist, Pendlebury, partly out of the New Parish (sometime District Chapelry) of Saint Anne, Brindle Heath, and partly out of the New Parish (sometime District Chapelry) of Saint James, Hope, all in the County of Lancaster and in the Diocese of Manchester:

"Whereas we are satisfied that the said New Parish of Saint John the Evangelist, Pendlebury, the said New Parish of Saint Anne, Brindle Heath, and the said New Parish of Saint James, Hope, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said New Parish of Saint John the Evangelist, Pendlebury, of the said New Parish of Saint Anne, Brindle Heath, and of the said New Parish of Saint James, Hope, which are hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas there has been contributed and transferred to our name a sum of £2,000 £5 per centum War Stock (1929-1947) towards the cost of erecting a permanent Church for the said proposed separate District:

"And whereas the said sum of £2,000 £5 per centum War Stock (1929-1947) has been contributed and transferred to us as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District, and when such District shall have become a New Parish, then of the said New Parish, and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

"And whereas the contributors of the said sum of £2,000 £5 per centum War Stock (1929-1947) towards the cost of erecting such permanent Church have nominated to us the Bishop for the time being of the said Diocese of Manchester as the person to whom they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

"Now, therefore, with the consent of the Right Reverend William, now Bishop of Manchester (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said New Parish of Saint John the Evangelist, Pendlebury, of the said New Parish of Saint Anne, Brindle Heath, and of the said New Parish of Saint James, Hope, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth upon the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme as aforesaid become and be constituted a separate District for spiritual purposes, and that the same shall be named 'The District of the Holy Angels, Claremont '

"And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid then of the said New Parish, and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in the said William, Bishop of the said Diocese of Manchester, and his successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of the Holy Angels, Claremont, comprising: —

" All those contiguous portions of the New Parish (sometime Particular District) of Saint John the Evangelist, Pendlebury, of the New Parish (sometime District Chapelry) of Saint Anne, Brindle Heath, and of the New Parish (sometime District Chapelry) of Saint James, Hope, all in the County of Lancaster and in the Diocese of Manchester, which are comprised within and are bounded by an imaginary line commencing at the junction of Claremont Road with Eccles Old Road where the boundaries of the said New Parish of Saint James, Hope, the New Parish of Saint Luke, Weaste, in the said County and Diocese, and the said New Parish of Saint John the Evangelist, Pendlebury, all meet, and extending thence eastward along the middle of Eccles Old Road (thereby following in part the boundary which divides the said New Parish of Saint Luke, Weaste, from the said New
