And whereas the said Archbishop being satisfied with the said Scheme has, under the provisions of the said Pluralities Act, 1838, by his Report dated the 10th day of December, 1925, certified the same and the Consents aforesaid to His Majesty in Council to the intent that an Order may, if His Majesty in Council so think fit, be made for carrying the Scheme into effect:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that the said

Scheme be carried into effect.
