Increase of Borrowing Powers.

Notice is hereby given that the Ministry of Agriculture and Fisheries has prepared a draft Order under the Land Drainage Act, 1918, altering the Acts of Parliament under which the above Commissioners act by conferring upon them edditional powers of borrowing money, and otherwise supplementing their powers in relation to drainage.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (Dated 8th January, 1926.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:---

Authorisation of Landing of Animals for Exceptional Purposes.

1. The landing of any ruminating animals or swine, the property of the Zoological Society of Scotland, which are intended for exhibition in the Gardens of that Society, is hereby allowed, subject to the provisions of Part II. (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the landing and detention of any such animals as may be landed in accordance with the provisions of this Order.

Examination before Landing.

3. No such animal shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animal has been examined by a Veterinary Inspector of the Ministry and certified by him to be free from symptoms of contagious disease.

Regulation Applicable to Animals on Landing.

4. Such animals on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Schedule hereto, and shall be there detained for a period of twenty-eight days or such other period as may be specified in the licence authorising the landing of the animals. During the said period the animals shall be kept separate from all other animals, and no other animal shall be moved into such premises.

FOOT-AND-MOUTH DISEASE DECLARA-TION OF INFECTED AREAS ORDER OF 1926 (No. 3).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Extension of Foot-and-Mouth Disease Infected Area.

1. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 2) shall be read and have effect as if the Area described in the Schedule to this Order were included in and formed part of the Foot-and-Mouth Disease Infected Area (No. 1) described in the First Schedule to that Order.
