## ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 16th January, 1926.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

- 1. This Order may be cited as the Penistone Registration of Births, &c. (Alteration of Sub-districts) Order, 1926, and shall come into operation on the first day of February, 1926.
- 2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 3. The Cawthorne Sub-district of Renistone Registration District shall cease to exist and its constituent Civil Parishes shall be apportioned as follows:—
  - (a) The Civil Parishes of Cawthorne and Kexbrough shall be added to and form part of the High Hoyland Sub-district of Penistone Registration District.
  - (b) The Civil Parishes of Silkstone and Thurgoland shall be added to and form part of the Penistone Sub-district of Penistone Registration District.
- 4. The Registrars of the existing High Hoyland and Penistone Sub-districts shall, respectively, be the Registrars of those Subdistricts as extended by this Order.
