LONDON COUNTY COUNCIL (GENERAL POWERS).

ADDITIONAL PROVISION.

THE London County Council (in this Notice called "the Council") intend to apply to Parliament by petition for additional provision for leave to introduce into the Bill promoted by the Council and now pending in Parliament under the title of "London County Council (General Powers)" provisions (hereinafter referred to as "the additional provision") the principal subject matters of which are as follows:—

Powers for the Council to construct a new street partly in the urban district of Barnes in the County of Surrey and partly in the Metropolitan Borough of Wandsworth in the County of London and provisions as to the vesting maintenance repair and lighting of the said new street and the bridge for carrying the same over the Beverley Brook; powers of acquiring by agreement and dealing with lands for the purposes of or in connection with the intended new street; contributions by the Surrey County Council the Barnes urban district council and the Wandsworth borough council towards the cost of constructing the said new street and the acquisition of lands; powers for those councils and the Council to borrow money and to mortgage or charge or expend their funds rates and revenues for the purposes of the additional provision; and power for the Council in connection with the provision of housing accommodation under the Housing Act 1925 or schemes made thereunder to provide and maintain buildings adapted for use for any commercial purpose
