EXPLOSIVES IN COAL MINES.

The definitions of the Explosives, Ligdinite No. 1, Negro Powder No. 2, and Stonobel have been amended.

The Explosives, Ammodyne, Capexco, Geligdynite, Ligdinite, Super-Ammodyne and Super-Ligdinite have been removed from the "Permitted List."
