WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT, 1925.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, Admiralty, the Army Council, the Air Council and the Minister of Pensions, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by proviso (1) to Section 24 (1) of the Widows', Orphans' and Old Age Contributory Pensions Act, 1925, and by the Contributory Pensions (Joint Committee) Regulations, 1925, to make regulations in conjunction with the Treasury relating to the administration of pensions payable to certain classes of persons to whom service dependants pensions are payable.
