FOOT-AND-MOUTH DISEASE DECLARATION
OF INFECTED AREAS ORDER OF
1926 (No. 29).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

*Declaration of Foot-and-Mouth Disease
Infected Areas.*

1. The areas described in the First Schedule to this Order are hereby declared to be Foot-and-Mouth Disease Infected Areas for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

Substitution of Area to which the Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1926 applies.

2. The Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1926 shall be read and have effect as if for the Area described in the Second Schedule to that Order there were substituted the Area No. 8 described in the First Schedule to this Order.

Revocation of Certain Orders.

3. The Orders described in the Second Schedule hereto are hereby revoked.

Commencement.

4. This Order shall come into operation on the fifteenth day of February, nineteen hundred and twenty-six.

Short Title.

5. This Order may be cited as the FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 29).

FIRST SCHEDULE.

1. An Area comprising:—

In the county of Lancaster.

The county borough of Barrow-in-Furness.

The boroughs of Morecambe and Lancaster.

The petty sessional divisions of Hawkshead including its detached part, North Lonsdale, South Lonsdale (*except the parishes of Over Wyresdale, Ellel, Cockersand Abbey, Cockerham and Thurnham*) and Hornby (*except the parishes of Tatham, Wray with Botton and Roeburndale*).

In the county of Westmorland.

The borough of Kendal.

The petty sessional divisions of Lonsdale Ward, Kendal, Windermere and Ambleside (*except the parishes of Grasmere, Langdales and Rydal and Loughrigg*).

2. An Area comprising:—

In the county of the West Riding of Yorks.

The city of York.

The petty sessional divisions of Eastern Ainsty and Tadcaster.

The parishes of Widdington, Nun Monkton, Thorpe Underwoods, Green Hammerton, Kirk Hammerton, Thornville, Cattall, Hunsingore, Tockwith, Bilton, Cowthorpe, Bickerton and Walton.

In the county of the East Riding of Yorks.

The petty sessional divisions of Ouse and Derwent (*except the parishes of Kelfield, Riccall, Barlby, Osgodby, Cliffe-cum-Lund, South Duffield and Menthorpe-cum-Bowthorpe*), Wilton Beacon, Holme Beacon (*except the parishes of Holme-upon-Spalding, Moor, Market Weighton and Abras, Goodmanham, Sancton and Houghton, North Cliffe and South Cliffe*), and Buckrose (*except the parishes of Yedingham, West Heslerton, East Heslerton, Sherburn, Ganton, Willerby, Weaverthorpe and Helperthorpe*), and the parishes of Bubwith, North Dalton, Tibthorpe, Wetwang and Sledmere, and also such part of the parish of Middleton-on-the-Wolds as lies to the west of the railway from Great Driffeld to Market Weighton.

In the county of the North Riding of Yorks.

The petty sessional divisions of Bulmer West (*except the parishes of Brafferton, Helperby, Thormanby and Myton-on-Swale*), Bulmer East and Malton, and the parishes of Harome, East Newton and Laysthorpe, Cawton, Stonegrave, Nunnington, Ness, Muscoates, North Holme, Great Edstone, Salton, Brawby, Normanby, Thornton Riseborough, Barughs Ambo, Little Habton, Great Habton, Ryton, Kirby Misperton, Pickering Marishes, Oswaldkirk, Gilling East, Grimston, Coulton, Thorpele-Willows, Yearsley, Oulston and Thornton-on-the-Hill, and also such parts of the parishes of Pickering and Thornton Dale as lie to the south of the railway from Kirkby Moorside to Scarborough.

3. An Area comprising:—

In the county of Lancaster.

The parishes of Pleasington, Witton, Livesey and Hoghton, and also such parts of the parishes of Tockholes, Withnell and Brindle as lie to the north of the following boundary namely:—Commencing at a point where the Blackburn-Bolton road enters the parish of Tockholes, and thence along that road in a southerly direction to a point near Ryal Fold proceeding therefrom in a generally westerly direction along the road leading to the Cherry Tree and Chorley Railway Line at a point near Withnell Mill, thence along that railway line to Brinscall Station proceeding therefrom along the road leading via Wheelton Stocks to Withnell Fold, thence in a north westerly direction along the footpath to the road leading to Brindle, thence along that road in a northerly
