His Majesty's Principal Secretary of State for Foreign Affairs has received from the Mexican Minister in London a communication, dated December 22nd, 1925, giving notice of the denunciation by the Mexican Government of the Treaty of Friendship, Commerce and Navigation between Great Britain and Mexico, signed at Mexico on November 27th, 1888, article 16 of which provides for the termination of the Treaty on the expiration of one year from the day on which either of the High Contracting Parties shall have given such notice.

The Treaty will accordingly terminate on December 22nd, 1926.
