Horse's head South.

Second portion.—Five carriages on South side of Station Road, commencing three feet from crossing at Walm Lane and extending Westward as far as necessary, keeping clear of the Waterpost and entrance to Railway Goods Yard.

Horses' heads East.

The first portion to be fed exclusively by carriages from the second portion.

APPOINTMENT OF STANDING FOR NINE HACKNEY CARRIAGES.

By virtue of the Act 13 and 14 Victoria, Chapter 7, intitled "An Act for Consolidating the Office of the Registrar of Metro-politan Public Carriages with the Office of Commissioner of Police of the Metropolis, and making other Provisions in regard to the Consolidated Offices.

WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Nine Hackney Carriages at Walm Lane, and Station Parade, Willesden Green, in two portions, and do make the following Regulations with regard to the boundaries for the same, viz. :-

First portion .--- One carriage on West side of Walm Lane, opposite No. 3, Willesden Green Station, keeping clear of North entrance to Station.

Front of vehicle toward the South.

Second portion.—Eight carriages on South side of Station Parade, commencing at a point in line with the party wall of Nos. $1\frac{1}{4}/16$, Station Parade, extending Westward, by kerb, as far as necessary for eight carriages, keeping clear of Entrance to No. 1, Chesham House and the Emergency Exit of the Station.

Front of vehicle toward the East.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

Provided that no hackney carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
